ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, **Vishwa Vishwas Educational Society, Plot No. 3-4-78, Sajidpura Street, Siddipet Town and Post Office, Siddipet Taluk and Town, Medak District – 502103, Andhra Pradesh** had submitted an on-line application to the Southern Regional Committee of NCTE on **31.12.2012** and submitted printouts on **07.01.2013** for grant of recognition or **B.Ed Programme of 100 Students at Greater College of Education, Plot/Khasra No. 165/a, Plot No.1, 1st Street, Majidpur Village, Shamirpet Post Office and Taluk, Shamirpet Town, Rangareddy District- 500078, Andhra Pradesh.**

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit submitted and the report received from VT and Videography, and the certificates received from the university, the Committee is satisfied that the applicant fulfils the requirements under the provisions of NCTE ACT, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, financial resources, etc., for running the programme.

NOW THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the of the NCTE ACT, 1993, the Regional Committee, NCTE hereby grants recognition to **Greater College of Education, Plot/Khasra No. 165/a, Plot No.1, 1st Street, Majidpur Village, Shamirpet Post Office and Taluk, Shamirpet Town, Rangareddy District- 500078, Andhra Pradesh** for conducting **B.Ed programme of two years** duration with an annual intake of **100 (Two Unit)** students from the academic sessions **2015-2016** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

- I. The Endowment fund of 5 lakhs and Reserve fund of 7 lakhs kept in joint account with Regional Director of NCTE should be maintained Perpetually. Loan raising against or mortgaging of FDR's shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in Position.
